Adrian Wootton OBE is Chief Executive of the British Film Commission and Film London. Adrian is a Programme Advisor to the BFI London Film Festival; Venice Film Festival and Noir in Fest, Milan; Founding Director of Shots in the Dark Festival, Nottingham and Curator of the annual Cinema Made In Italy programme, London.

Adrian is a recognised authority in various film/TV and literature subjects (Hollywood, crime and mystery and Italian Cinema amongst others) and regularly lectures, writes broadcasts and curates programmes on them.

In 2012, Adrian received an Honorary Doctorate in the Arts and was appointed Visiting Professor of Film and Media at Norwich University of the Arts. In 2014, Adrian received an Honorary Doctorate of Letters from the University of East Anglia and in 2017 was awarded an OBE for services to the film industry.

Most recently, Adrian has led the BFC's work to develop the *'Working Safely During COVID-19 in Film and High-end TV Drama Production guidance'*, as part of the BFI's wider COVID-19 Screen Sector Recovery Task Force.



Samantha Perahia MBE
Head of Production UK, UK Office

Samantha worked in theatre and film and television production, post production and locations before joining the British Film Commission (BFC) in 2004.

As Head of Production UK, she leads the UK team, providing tailored production support, guidance and troubleshooting to major international film and television projects. She additionally oversees the BFC's work supporting and promoting the UK film and television infrastructure globally and is responsible for liaising between the industry and Government to secure and maintain production-friendly policies.

Samantha worked closely with Government and industry in developing the UK's Creative Sector Tax Reliefs and was instrumental in the creation of the BFC's *'Working Safely During COVID-19 in Film and High-end TV Drama Production guidance'*.

Samantha has assisted on many high-profile projects for international television, film and streaming clients including A+E, Amazon Studios, Amblin, AMC, Apple, CBS, Disney, HBO, Lionsgate, Lucasfilm, Marvel, MGM, MRC, Netflix, Paramount, Sony, Universal and Warner Bros.

She was awarded an MBE in the Queen's New Year Honours List 2019 for services to the film and TV industry.

Kattie leads the effort in the US to build upon the excellent levels of international productions coming into the UK and ensures the US film and television industry continues to utilize the UK's world-class production infrastructure and talent base. Kattie works with studios, producers, agencies and executives to identify projects best suited for the UK and fully support them throughout their time in Britain. Kattie functions as a key liaison between the UK and US film and television industries on a number of other levels by participating on panels, attending festivals/markets and partnering with relevant organisations to support the BFC's mission.

Prior to her work at the BFC, Kattie spent nine years working with National Geographic Films (NGF) as Vice President of Acquisitions and Production. Kattie's early film career included working in development at Fox Searchlight Pictures and in marketing at Paramount Pictures.

She began her professional career in Chicago as a consultant with Andersen Consulting after graduating with a Bachelor of Arts degree from the University of Virginia.

The British Film Commission (BFC) is the UK Government's national organisation responsible for international film and television production in the UK. We lead on:

- Maximising and supporting the production of major international feature film and High-end television in the UK;
- Strengthening and promoting the UK's film and television infrastructure;
- Liaising between the Government and the film and television industry on policy issues that impact on production.

With offices in the UK and the US, we provide free, tailored production support at the highest level, from the earliest stages of development through to post-production, including guidance on the UK's competitive film and television tax reliefs and assistance with sourcing key crew, studios, facilities and locations.

Our industry sponsors form the membership of the agency's innovative public/private partnership ensuring strong, independent and accountable industry input which further guarantees that our policy contributions are relevant and feasible.


Working with our UK Nations and Regions

Whether sourcing key crew and stage space, or advising on visas and tax relief, we provide a single point of contact for international productions looking to produce content in the UK, from development through to post-production.

We partner with colleagues in the screen agency network that provides full coverage of all four UK nations – England, Northern Ireland, Scotland and Wales – from supporting new stage space development to location troubleshooting.


Our Impact

With **£4.713bn** spend in the UK, 2021 was a record year for inward investment into film and High-end TV.

With our support an additional **800,000 sq.ft.** of UK stage space capacity has been delivered over the past two years. This increase is equivalent to **25%** of pre-existing UK stage space.



UK Production Hubs

The UK boasts major production hubs throughout its nations and regions.

- Suitable for feature film and High-end TV, a range of purpose-built studios, stage conversions and alternative build space is accessible throughout the UK, with a pipeline of new stages in development.
- Conveniently located in **seven** major UK production hubs, with access to experienced and skilled crew, good transport links and other screen sector infrastructure.
- Thousands of square feet of backlot and specialist shooting facilities include virtual production stages and volumes, performance capture, and unique assets including Europe's largest underwater stage.
- We provide production and location support throughout the UK.



UK Production Hubs

1. London and South-East England
2. South-West England (Bristol)
3. North-West England (Manchester and Liverpool)
4. Yorkshire, England (Leeds)
5. Northern Ireland (Belfast)
6. Scotland (Glasgow and Edinburgh)
7. Wales (Cardiff)

Accessing UK Tax Reliefs

We assist productions with guidance on the UK's competitive and inclusive tax reliefs for qualifying film, High-end TV, animation, children's TV and video games.

- Claim up to 25% on UK-based activity, including pre-production, production, VFX and post-production.
- Above-the-line is included, irrespective of nationality.
- No cap on the amount that can be claimed per project and no annual cap.
- Interim claims can be made.
- Direct cash rebate; no 'middle men'.
- Unrivalled pay-out times.
- Ability to switch between reliefs after production has started.
- Unaffected by the UK's exit from the EU and supported by all main political parties.
- No sunset date.
- For every £1 of film tax relief claimed, tax credit returned over £8 in GVA for UK economy.

Boosting Additional Studio and Stage Space

Acting as a one-stop-shop, we provide support in the following areas:

Site Identification and Feasibility

We help identify appropriate real estate, make introductions to property consultancies and others in the development sector; and undertake feasibility assessments of development proposals and conversion opportunities to ensure they meet the needs of the global screen industry.

Industry Research

We provide bespoke research into the latest approaches to infrastructure development, including the integration of renewable technologies and stage space design, as well as data on access to crew, studio specific local impact assessments and economic analysis.

Professional Support

We enable access to a UK-wide framework of sector professionals, providing expertise in multiple disciplines, from architecture and design, to acoustics and sustainability, national and local authority regulatory frameworks and support for planning applications.

Stakeholder Introductions

We facilitate bespoke introductions to UK-wide stakeholders in the sector. We work closely with national and regional partners to support the establishment of new infrastructure across the UK.



Skills and Training

With demand for content at an all-time high, and significant studio and stage space developments and expansions underway across the UK, supporting the UK's skills pipeline is a priority.

We work closely with UK industry and partners to:

- **Identify and address** skills gaps across the spectrum of High-end TV and feature film production roles.
- **Facilitate crews' access** to suitable training.
- **Fund bespoke skills and training initiatives** that help build the crew bases in the UK's nations and regions.
- **Connect and help build relationships** between US clients and UK training providers to continue to grow skilled crews.
- **Connect production clients with relevant organisations** to address differences between UK and US working practices and develop training accordingly.
- **Share recent productions' experiences** to inform and shape skills development strategies.

Supporting Environmental Sustainability and Social Responsibility

As the UK's production hubs expand to meet the increased demand for content, ensuring they maintain the highest social and environmental responsibility standards is increasingly important.

We provide support on:

- **Improving health, safety and well-being** for productions/on set through COVID-19 Production guidance.
- **Mental health and Diversity, Equality and Inclusion workshops and training.** We work with partners and organisations to deliver wellbeing initiatives for productions, and continue to identify areas for training and support.
- **Supporting our sector's transition to zero-carbon** – working with industry and stakeholders to facilitate access to appropriate resources and expertise to establish and achieve sustainability goals.
- **Identifying and unpicking challenges** that our production clients may face in translating their US initiatives to the UK context, and aligning bespoke support with our shared EDI and sustainability goals.
- **Partnership working and learning from,** and sharing best practice with other film commissions, industry and stakeholders.

VFX, Post-Production and Animation

- **The UK has the largest concentration** of VFX and post-production talent in the world.
- **The UK is home to some of the biggest and most successful VFX and post-production facilities**, as well as boutique facilities, based in each of the UK hubs.
- **The UK is rapidly becoming a global centre of excellence** in the knowledge and adoption of new in-camera-VFX techniques.
- **There are now over 30 dedicated virtual production stages and volumes** available throughout the UK.
- **Qualifying Film and HETV productions** carrying out only VFX/Post work in the UK are still eligible for tax relief if the minimum expenditure requirement is met.
- **The UK features highly successful centres of animation** excellence in each of the four nations, generating globally successful IP as well as providing specialist animation services.
- **We can provide guidance on the depth and diversity** on the UK-wide VFX, Post-Production and Animation industry. British Film Commission's Working Safely During COVID-19 in Film and High-end TV Drama Production guidance

As the world learns to live with COVID-19, the BFC's *Working Safely During COVID-19 in Film and High-end TV Drama Production guidance* remains an essential tool in keeping crew and cast safe, and productions working. Used alongside the productions' own COVID-19 protocols and production-specific risk assessment, it is intended to provide high-level guidance to manage COVID-19 specific risk producing film and High-end TV drama in the UK.

The guidance was prepared in consultation with and crew representatives, UK and US film and High-end TV production executives, industry bodies in four nations of the UK and in consultation with the Government, UK Health Security Agency and the and Safety Executive.
